

## **2015 Cincinnati Auto Expo Forum Car Contest**

### **No Purchase or Entry Fee Necessary**

1. All vehicle owner contestants must be 18 years of age.
2. At least three vehicles will be chosen to be exhibited for the duration of the 2015 Cincinnati Auto Expo at the Duke Energy Convention Center from Wednesday, February 18 through Sunday, February 22, 2015.
3. Eligible vehicles include but are not limited to:
  - a. Classic/Old School
  - b. Tuner
  - c. Muscle/Hotrod
  - d. Specialty
  - e. Exotic
  - f. Otherwise rare or unique
4. Contest begins Friday, November 14, 2014. Voting deadline is Friday, January 16, 2015.
5. To enter, simply submit a recent photograph (within the past year) of the vehicle. Entries may be submitted to [contestcar@gcada.net](mailto:contestcar@gcada.net) or [www.gcada.net/carcontest](http://www.gcada.net/carcontest).
6. Prior to the posting of the vehicle, the Greater Cincinnati Automobile Dealers Association must receive confirmation from the vehicle's owner that the vehicle will be available for display and that the owner agrees to comply with the rules of the contest and display at the Auto Expo.
7. From the entries received, Facebook voters will "like" their favorite vehicles to determine the finalists. At least three winners will be determined by judges selected by the Greater Cincinnati Automobile Dealers Association. All decisions made by the judges shall be final. The winners will be invited to exhibit their vehicle during the 2015 Cincinnati Auto Expo at the Duke Energy Convention Center.
8. Winners will be contacted by a representative of the Greater Cincinnati Automobile Dealers Association.

#### **By submitting an entry to this contest winners must agree to the following:**

9. Winners must agree to abide by all display rules established by the Duke Energy Convention Center, Fire Department, or Auto Expo management. These requirements include but are not limited to having less than 1/8 of a tank of fuel, the gas cap must be taped, battery cables disconnected, and turning in one (1) set of keys to Auto Expo Management.
10. Vehicles must be available for display at Duke Energy Convention Center from Monday, February 16 through Monday, February 23, 2015. No vehicles will be permitted to be removed from the exhibit prior to move-out at the end of the Auto Expo.
11. Neither Hart Productions, the Great Cincinnati Automobile Dealers Association, any sponsor, the Duke Energy Convention Center, nor any officer, director, or shareholder thereof shall be responsible or liable for any loss or damage to all or part of the winner's vehicle, trailer, display, material and or parts associated with displaying vehicle. Winners hereby waives any and all liabilities, claims, judgments, demands, controversies, agreements, damages, actions and causes of action whatsoever, either in law or in equity, against any other persons, firms or corporations which Claimant, his heirs, executors, administrators, successors and assigns can, shall or may have by reason of, or in any way incident to or resulting from the aforementioned event at any time.
12. Winners agree to have insurance coverage for the above listed items and assume full responsibility for any loss or damage.
13. No commercial advertising is allowed to be displayed with the contest vehicle.
14. Winners agree that Hart Productions, the Greater Cincinnati Automobile Dealers Association or their assigns shall have the right, free of charge, to publish and/or broadcast by any means the name, city of residence, photographs, video, and statements of the winner.
